PROCEEDINGS OF THE STATE LEVEL TECHNICAL COMMITTEE (SLTC) MEETING TO FIX SCALES OF FINANCE FOR THE YEAR 2021-22 HELD ON 06.03.2021 at TSCAB, H.O., HYDERABAD.

The State Level Technical Committee (SLTC) meeting of Telangana State was convened on 06.03.2021 at TSCAB, Head office. The Managing Director, TSCAB (Convenor, SLTC) welcomed Dr. B. Janardhan Reddy, IAS, Agriculture Production Commissioner (APC)/ Secretary to Govt. of Telangana (Chairman, SLTC), Bankers and other members of the committee and emphasized the importance of fixing Scales of Finance (SoF). The convenor stated that the lead role for fixing the Scales of Finance is given to the Cooperative Banks. Based on the Scales of Finance recommended by the District Level Technical Committees (DLTCs), SoF are finalised by obtaining the suggestions and inputs by the Committee members. Further, the convenor gave a detailed snapshot of NABARD revised broad based guidelines like Re-constitution of DLTC & SLTC, timelines, notification. As per the revised guidelines the SLTC is given the power of approving the SoF recommended by the DLTCs. The convenor explained the method of arriving at the SoF and requested the delegates to actively participate and offer their valuable suggestions to fix and adopt the Scales of Finance for 2021-22 and also advised all the members to give wide publicity of SoF and also place in their respective websites once the SoF is notified.

In his opening remarks, the chairman of the SLTC Committee, Dr. B. Janardhan Reddy, IAS, Agriculture Production Commissioner (APC)/ Secretary to Govt. of Telangana, stated that Telangana state is emerging as the topper in Agriculture sector. Further, the chairman has expressed his views by clearly explaining about the agriculture scenario and also the achievements made by the Telangana state in Agriculture sector. He informed that 211 lakh acres of area is cultivated in Telangana state, out of which Paddy is cultivated in 105.80 lakh acres of area followed by Cotton (around 60lakh acres), Red gram (around 10.80 lakh acres), Maize (around 6 lakh acres), Soyabean, Bengal gram, Green gram and Other Horticulture crops etc. In case of cultivation of fruits, Mango stood at top followed by Acid lime, sweet orange. In case of Commercial crops, Red chillies stood at top followed by Turmeric. The Chairman of SLTC also informed

that, the Telangana state stood at top in Oil palm cultivation and also explained various factors favouring and also the problems being encountered for cultivation of oil palm. The chairman has requested GoI/NABARD to increase subsidy and other incentives for cultivation of Oil palm.

The Director of Horticulture Dept has appreciated the keen commitment of Govt. of Telangana in encouraging Oilpalm cultivation. Further stated that Telangana state has potential for 8.14 lakhs acres of area which was notified by the GoI expert committee covering 25 districts in the state for cultivating Oil palm. Smt. V. Sarojini Devi, JDH, Horticulture Dept has made a detailed power point presentation (PPT) on the prospects and strategy for Oil palm cultivation in the state of Telangana.

The members of SLTC had detailed discussions on the cost of cultivation, value of gross yield basing on Agroclimatic conditions of each district pertaining to all major crops and approved suggestive range of Scales of finance, taking into consideration of the local factors including cost of labour etc.

The officials from Departments of Cooperatives, Agriculture, Horticulture & Sericulture, Animal Husbandry, Agriculture University. Veterinary University NABARD, SLBC, SBI, Union Bank of India, Punjab National Bank, Canara Bank, Bank of Baroda, APGVB and Telangana Grameena Bank, have recommended realistic Scales of Finance for various crops and working capital requirement for Animal Husbandry and Fisheries activities.

After detailed deliberations, the committee resolved for adopting 3 guiding principles for fixing SoF as:

- (i) Scales of Finance of respective DLTC should not be more than SLTC approved Scales of Finance.**
- (ii) But in any of the particular district, if SoF of 2020-21 is higher than SLTC approved SoF for 2021-22, then the SoF of 2020-21 should be retained.**
- (iii) Where ever the DLTC SoF for the year 2021-22 is lower than the SLTC approved SoF range, it should adhere to the lower SoF only.**

State Level Technical Committee advised that newly formed Districts should follow the Scales of Finance fixed by DLTCs of erstwhile Districts/DCCBs.

State Level Technical Committee advised that newly formed Districts should follow the Scales of Finance fixed by DLTCs of erstwhile Districts/DCCBs.


The Assistant Director of Agriculture Department has shared their experiences and extended valuable suggestions in fixing of Scales of Finance of major Agricultural crops.


Further, the Committee observed that there is huge gap in Scales of Finance for most of the crops recommended by the DLTC of Adilabad for the year 2021-22 when compared to the SoF of 2020-21.

The representative from Animal Husbandry Department has expressed his views by giving detailed explanation of working capital components for fixation of Scales of Finance under Animal Husbandry. Further, Dr. Srinivas Mohan, DGM NABARD(Retd) has also made few recommendations to fix SoF for Animal Husbandry activities.

It is observed by the committee that, there is no representation from Fisheries Department. However, they have furnished working capital requirement under fisheries and the same were discussed in the meeting.

The crop wise Scales of Finance fixed by the SLTC for various crops and also the working capital requirement for Animal Husbandry and fisheries activities for the year 2021-22 are enclosed.






